

Interim Report: Six Month Observations (and follow-up from three-month report) Rev. Jeff Binder January 9, 2024

Introduction

The six-month mark seems like a natural time to move beyond our initial observations and assessment to that of envisioning the future for First Presbyterian. Over the past six months we have achieved great things by re-instilling trust among congregants and leadership, offering quality worship experiences, addressing administrative needs and practices, and offering a sustainable, stable pastoral presence.

This new year will begin with a formal congregational assessment using the "Conversations" material offered by *Holy Cow!* consulting. Following this assessment, I will facilitate a third workshop for the congregation that will introduce possible future ministry options for smaller congregations today.

First Presbyterian's current realities are becoming more apparent. We are no longer living in the past from memories of "the good old days." We are no longer operating from the instability and anxiety of pandemic life of the past four years, or even from the more recent pastoral transition. This is an appropriate time for this church to begin to envision its future, and most importantly, to listen for God's voice within such a process.

Property/Facility

The church campus continues to serve as a source of identity, nostalgia, inspiration, and responsibility for this congregation. One interesting observation is that the buildings become "common place" after six months of ministry. I no longer look at the crumbling walls with the same urgency I initially had. I don't see the emptiness of the sanctuary I did upon my first time preaching there. In some ways this is a good thing; it's a reminder that the building has "staying power" for years to come—it's not going to fall down tomorrow! With another perspective, however, it's a reminder that many members of First Presbyterian have become de-sensitized to the issues of the building, both cosmetically and functionally.

Instead of noting the current building issues (these are discussed at most monthly session meetings), I offer some rhetorical questions as First Presbyterian moves ahead:

- 1. What role does this campus play in the mission of First Presbyterian?
- 2. If the church building was no longer here tomorrow, what would be missed the most?
- 3. If you could envision a brand-new church to build, what would it look like?

Worship

A few people have asked the question, "What about us going back to the chapel for Sunday worship?' That's a fair question, given the size of the current congregation and active worshipping attendance (about 25 worshippers at this time).

There are pros and cons, of course, to worshiping in the chapel. I typically respond to such a question with a follow-up question that addresses the elephant in the room: "What do you do with the sanctuary?"

Worshipping in the sanctuary also has its pros and cons.

Both spaces are great options for Sunday worship, but is that what worship is all about? I am inclined to remember the very first Christians, and how they did not let a physical space define their expectations for worship life. And so, I ponder for First Presbyterian today as well:

- 1. What compels us to worship on Sundays?
- 2. How do you perceive a first-time visitor experiences worship at First Presbyterian?
- 3. How might God be calling First to re-imagine worship moving forward?

Session

We have a new class of two elders joining us on Session this year. One observation is that this congregation was unable to fill all three slots this year, and that those rotating off did not want to entertain the idea of returning in this moment. On top of this, the Clerk of Session has also resigned this year. Suffice it to say, there are several roles to fill, and not many volunteers stepping forward. Session will also be shaping the conversation for congregational decisions in the year to come as well, which is especially pertinent during an interim period. I am hopeful that the trust we have been establishing over the past six months will pay off with productive and loving ministry and mission in the months ahead.

My hope for Session moving forward is that we continue to develop our emotional intelligence and teamwork as a group by continuing with active listening, inviting honest communication, and making sure that participants feel heard, safe, and valued. The day to day work and decisions will always be part of the life of Session, but I am inspired by how this group continues to develop more as a team in the days to come.

Congregational Care

Congregational care continues to be a priority for an aging congregation. Several members are now homebound, and others have stepped away during the most recent pandemic and conflict. How is the church meeting their needs for community? While I appreciate making pastoral visits, my role as an interim is more about empowering other church members to meet some of these needs as we strive to understand the collective call to ministry as the church. How are we documenting the care that we are making so that no one is falling through the cracks?

The Congregational Life committee and Presbyterian Women both serve as positive sources of support for this needed ministry.

Staffing

A larger question of staffing needs will take place as this church make plans for the future. While the staff here perform well and are appreciated for their efforts, the question remains as to the efficacy of the current structure in the days ahead. Is a full-time pastor still needed? How about other staff? Annual reviews have taken place for Heidi and Renee, both of which were celebrated, and both appreciative of the Session support. I would like to have a six-month review, as we as a Session also need to discern the future of my role as your interim minister. Some questions to ponder regarding staff:

- 1. Does the current staff structure reflect the ministry/mission needs of the church?
- 2. How might the church best support the staff moving forward?
- 3. Is the Personnel budget appropriate for this church?

Finance & Stewardship

When the Administration committee met in September, it was agreed to move forward with a stewardship campaign and a budgeting process. Both of these processes were completed in 2023, with an understanding that ongoing work in both areas will continue to be addressed throughout the year. While a stewardship campaign is not the only indicator of congregational vitality, it does present a good picture of activity, commitment, and vision for the future.

Session will continue to receive monthly financial reports from the treasurer(s). However, the larger questions of financial sustainability remain related to the ministry of the church:

- 1. How much deficit within the operating budget is acceptable for this Session?
- 2. How will Session prepare for the next unexpected expense related to property maintenance?
- 3. How can the endowment be used as a tool for ministry and mission moving forward?

Mission & Outreach

Mission continues to energize congregations near and far. In fact, most vital congregations have a good understanding of missional partnerships and participation as the central part of their identity. Stephany has been initiating several mission opportunities over the past year, although response from membership has been varied. Mission is the central component to First Presbyterian realizing a dynamic future ahead.

- 1. What do our neighbors need from the church?
- 2. How does First Presbyterian understand its missional identity today?
- 3. How will this church invite and equip others who are not currently actively leading to take on future leadership in the church?

Presbytery

Session will continue to work with the presbytery within the "Conversations" assessment in the coming months. This assessment will not provide answers for "what to do next," but it will provide some intelligible information on the current realities of the congregation. Beyond our own internal conversation on future options for this congregation, my hope is that we can coordinate a time with other local congregations of similar circumstance, along with the presbytery, to discuss future options together.

Moving forward:

Following the "Conversations" assessment, we are invited to begin to make plans to move forward as a congregation. Some of the conversations that will need to take place include decisions that will not be unanimous or easy. Other decisions will create fertile ground for new days of ministry and mission ahead. In all of it, we need to remind ourselves and one another that this is a practice of faith for us as people of faith. May we be courageous, grace-filled, and Spirit-led in the months to come.

Treasurer's Report 2023

First, we want to thank our "Enablers". These are the special people in our church that help your treasurers perform their functions. Our previous treasurers, Catty Clem and Deborah Norville, kept a steady hand during some challenging times for our church. Rhonda Ritchie, in her role of bookkeeper and payroll specialist, publishes the account-by-account reports we use to keep track of the financial position of our church. Pastor Jeff, for his leadership as Interim Pastor and his focus on re-stabilizing our church and supporting your present Treasurers in performing their financial responsibilities. Lastly, and most importantly, our Office Manager, Heidi Marsh, as she implements the many facets of her job with particular skill while maintaining her friendly and helpful demeanor.

The Treasurers main function is to collect and deposit monies, sign all checks on behalf of the church, and to give Session some management reports which allow them to monitor the health of the church and to help in guiding future actions.

Our Income Statement shows how the church performed in the areas of income and expense. Our church received income of \$347,100.56 and had expenses of \$255,814.63 for a total Net Income of \$91, 285.93. Of the total income, \$124,240 came in as the result of pledges. The rest of the income is proceeds from rent, unpledged offerings, trust income and specific bequests. That income was unusual as proceeds from Trusts and Estate donations supplemented our income. Our expenses are largely driven by both property expenses in support of our buildings, and from payroll expenses. Both categories were unusual as we replaced our A/C system in the sanctuary (over \$100,000) and our payroll expense only reflected a partial year of Pastor as Interim. These two factors will not repeat themselves in 2024.

Our Balance Sheet shows the longer-term financial position of our church as it reveals total assets and liabilities. It includes such things as cash on hand, endowment and memorial funds as well as fixed assets such as our new A/C installation. Our Total Assets as of December 31 are \$1.598,950.54. This compares with assets of \$1,165,238.13 in 2022.

Your treasurers believe we are at an inflexion point in the life of our church. While we still have the financial resources to make a difference in our community and world, the simple fact of our diminishing congregational giving and the continued draw of building maintenance on our expenses call for some inspired leadership from your Session and a renewed push from our congregation for increased financial and volunteer support. The next several years will reveal the choices we make.

Thank you to Scott Wilson and Amanda Avery for serving as Treasurers. Session has especially appreciated a monthly financial update.

Thanks to Stephany Morgan and Jenny Dixon for serving as our Trustees.

Special thanks to Jenny Dixon. Jenny has completed her term as Trustee. Thank you for serving.

Music Director's Report 2023

At the beginning of the year we had an adjustment period when Otto, our Organist and technical resource guy, left.

The use of the chapel for services was well-received. One of the Speakers on the wall was re-connected which helped those hear in the Chapel.

Many thanks should go to Scott Wilson, Gary Havens and Robert Richardson who helped out with singing, playing piano and percussion, in the program early on.

Recording in the Chapel was uploaded to the Internet / Facebook via personal Cell-phone by Sam Clem or Renee Huff. Thanks to our new Interim Pastor, Jeff Binder, for allowing us to use his Camera Stand for recording.

After several Sundays the actual Microphone from the Pulpit in the Sanctuary was brought over and used in the Chapel for an easier listening experience.

Once the congregation moved to the Sanctuary the issue of Sound clarity, organ function, and recording/uploading processes began.

Many Thanks should be given to Sam Clem who has had to continually troubleshoot and run the Sound system / online streaming platform each Sunday.

• The Magewell recording device in the Sanctuary is what allows us to connect the in-house camera video-stream directly to the Church's FaceBook page. The challenge is that FaceBook updates and changes their upload coding requirements (establishing new hoops to jump through) for no rhyme or reason that can be detected, causing the streaming process to malfunction. Sam's expertise and many years of computer savvy have indeed worked to the church's advantage. Many months of 2023 were a challenge to properly set-up - as protocols and permissions were elusive and very intricate to determine. Throughout the year, there was always the possibility that the permissions would reset every Sunday, so it was never known would have to be done that day. Sam arrived more than an hour before the service, often through the week, to figure out what was necessary before recording every Sunday!

- CONCERNS FROM CONGREGATION reported- Sound quality issues were discussed.
 Congregants noticed a lack of clarity and couldn't hear during the service. The impaired quality might be helped by converting the old desktop computer in the balcony (that Otto gave us), vs. a newer laptop for processing speeds.
- Discussions were had about our internal sound system quality issue due the lack of our Overhead Speaker in the Sanctuary being in place. Communication with Otto Pebworth was required to proceed.

In the Fall, we are happy to report the Handbell Choir started back up again after a long absence, and performed beautifully during the holidays.

Annual Evaluations occurred in October and some planning was done for getting the main speaker put in place (ceiling of Sanctuary) sometime next year. We will coordinate with Otto for connections.

A decision was made to purchase a headset microphone for the pastor. If we considered an all-in one-kit/ combo units (receiver, bodypack and headset) they begin around \$700.00 on sale. Otherwise, they ranged from \$700 to \$3,000! As we already had the receiver, we thought we could use that and pair a new bodypack/headset to it. Well, turns out lots of research later, there are four different types of body packs and microphones that can work for our receiver. The ONE perfect match body-pack is no longer being made – so all of the options left were tricky. We bought these (below) and Sam cleverly worked with the sales rep and figured out how to pair them in-house. Ask Sam for the whole delightful story.

New Outreach Efforts in 2023

Home Goods Pantry: Opened July 2023

First Presbyterian and Second Presbyterian joined together to invite other local churches to each provide breakfast, lunch, and dinner for one day while the WARM guests were residing at Expo, the week of March 18 – 25, 2024. We have been successful in making that happen. First Presbyterian will provide the Sunday evening meal, March 24th, and Monday, March 25th, breakfast and lunch.

Property Committee Report

Following is a year-long look into what has been accomplished by property and what still needs to be addressed.

- 1. Largest item for the property was the undertaking of the AC systems in both sanctuary and Frasier buildings. These systems are new and more efficient, giving us years of life as well as reducing electric bills.
- 2. The doors on the front of the sanctuary have been completely sealed and repaired.
- 3. There have been several maintenance issues with the roof. Those have mostly been addressed and we now have a contract with the roof company to clean gutters on a biannual basis to stop us from having roof leaks.
- 4. Frasier building has had upgrades from leaks in the roof that caused the uppers floors to have ceiling collapses. They have been repaired and rooms repainted. The parlor in the Frasier also has some water damage and that space was repainted and repaired, looking better then ever.
- 5. Church kitchen has had some upgrades and repairs. The dishwasher was serviced and is working fine now, as well as the addition of two new stoves and two new refrigeration systems.
- 6. Boiler system has been serviced and worked on. It is still a costly expense due to age and size; also finding parts are not easy and are also costly. This is something property will have to address in the future.
- 7. Lastly, the church elevator is down. The service team will be out to repair in a couple of weeks. Property wishes everyone at first Presbyterian church a happy and wonderful 2024.
